## LICENSING FEE SCHEDULE

(as of March 2025—subject to change without notice)

- Fees may apply to any request with the exception of image files of public domain objects from the Indianapolis Museum of Art collection and the Newfields Archives collections that are available for free download through Newfields' Open Access program.
- Licensing requests are accepted by completing the online Licensing Request Form or by emailing [permissions@discovernewfields.org](mailto:permissions@discovernewfields.org).
- Physical materials furnished and sent by Newfields via FedEx or similar carrier will be shipped with an account number furnished by the applicant.
- Files will not be provided to the applicant until the payment of fees, if applicable, is received by Newfields.
- Newfields requests one gratis copy of any publication or project containing content from Newfields.
- Negotiations for royalties, exclusives, and/or in-kind merchandise will be made at the time of application.
- *Provided content must not be used to assert or imply Newfields endorses any commercial product or enterprise, concurs with the opinions expressed in, or confirms the accuracy of any text used with these reproductions.*

### SCHOLARLY USE (*Distribution up to 10,000 copies or 10-year term*):

- Content and file(s) will be provided for scholarly uses free of any reproduction fees.
- Preparation fees may apply if new photography or scan is required to provide a high-resolution file.

### PERSONAL USE:

- Prints or files that are provided are **not for reproduction**. Print fees are quoted individually.
