# Newfields celebrates historic year at 136<sup>th</sup> Annual Meeting

Volunteers recognized for exemplary service, new board members elected

**INDIANAPOLIS**, May 30, 2019—At its 136<sup>th</sup> Annual Meeting, Newfields celebrated another successful year, including \$21.7 million in recent grants and gifts, new art acquisitions, exciting exhibitions and the continued success of *Spring Blooms* and *Winterlights*. In its second year, the *Winterlights* celebration exceeded projected attendance and attracted more than 111,000 guests. This marks the largest attendance for a Newfields' exhibition or event in its history.

During the meeting, two volunteer leaders were recognized for their lifetime achievement and contributions. Awarded annually, the Distinguished Service Award honors exemplary leadership, support and service to deserving individuals. This year's 2019 Distinguished Service Award recipients are Lori Efroymson-Aguileria & Sergio Aguileria.

In 1998, Lori and her late husband, Dan Efroymson, established the Efroymson Family Fund. After Dan's passing, Lori and their two children, Jeremy and Elissa, continued the Efroymson Family Fund philanthropic legacy. In 2004, Lori and Sergio Aguilera married and together have tirelessly supported arts and culture initiatives. Sergio and Lori have been involved with Newfields for close to two decades, each having served on the Board of Trustees.

In 2005, the Efroymson Family Entrance Pavilion opened as a space where guests have their first experience with art at Newfields and in 2006 the Efroymson Family Contemporary Art Fund was endowed by the Efroymson Family Fund to support work by emerging contemporary visual artists through a rotating installation program in the Efroymson Family Entrance Pavilion. Currently, *Studio Drift: Meadow* is on display in this pavilion and will be until February 23, 2020. From 2014 to 2018, the Efroymson Family Fund supported the ARTx series. The series was designed to draw in new audiences and set Newfields on its current programmatic course in many ways.

During the Annual Meeting, three new Board of Trustees members were elected, and four new Board of Governors members.

# **Nancy Carpenter**
